A BILL FOR AN ACT

RELATING TO OUT-OF-STATE SALES OF TIME SHARE INTERESTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 514E-30, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "\$514E-30 Scope of chapter. (a) This chapter applies to 4 the offer and sale in Hawaii of time share interests in time 5 share units located in Hawaii. If time share units are located 6 outside of Hawaii, but any offer or sale is made within the 7 State, this chapter, except for sections 514E-3, 514E-4, 514E-5, 8 514E-6, 514E-7, and 514E-14, shall apply. As to the offer and 9 sale in the United States, but outside of Hawaii of time share 10 [interest] interests in a time share plan which includes time 11 share units located in Hawaii, this chapter, except for sections 12 514E-2.5, 514E-8, 514E-9, 514E-10(b) and (c), 514E-11, and 13 514E-11.1 shall apply. 14 (b) Notwithstanding subsection (a), with respect to a time 15 share plan containing accommodations or facilities that are 16 located in a currently registered Hawaii time share plan, which **17** is promoted and offered for sale only outside the jurisdictional

limits of the United States, such offer or sale shall be exempt

5	chapter,	or pay an exemption registration fee of \$100 and file

8	(1)	The name and address of the time share plan;
9	(2)	The name and address of the developer and seller, if
10	·	any;
11	(3)	The location and a brief description of the
12		accommodations and facilities, if any, that are
13		located in Hawaii;
14	(4)	The number of time share interests and duration to be
15		offered;
16	(5)	The term of the time share plan;
17	(6)	A copy of the time share instrument relating to the
18		management and operation of accommodations and
19		facilities, if any, that are located in Hawaii;
20	<u>(7)</u>	A copy of the budget required by section 514E-9;
21	(8)	A copy of the management agreement and any other
22		contracts regarding management or operation of the

1		accommodations and facilities, if any, that are	
2		located in Hawaii, and which have terms in excess of	
3		one year; and	
4	<u>(9)</u>	A copy of the provision of the contract to purchase an	
5		interest in a time share plan to be utilized in	
6		offering the time share plan containing the following	
7		disclosure in conspicuous type immediately above the	
8		space provided for the purchaser's signature:	
9	"The	offering of this time share plan outside the	
10	jurisdict	ional limits of the United States of America is exempt	
11	from regu	lation under Hawaii law, and any such purchase is not	
12	protected	by the laws of the State of Hawaii. The management	
13	and opera	tion of any accommodations or facilities located in	
14	Hawaii, h	owever is subject to Hawaii law and may give rise to an	
15	enforcemen	nt action regardless of where the offer was made."	
16	<u>(c)</u>	Time share interests that are part of a time share	
17	plan exem	pt under subsection (b) shall not be resold in the	
18	United Sta	ates."	
19	SECT	ION 2. Statutory material to be repealed is bracketed	
20	and stricken. New statutory material is underscored.		
21	SECT	ION 3. This Act shall take effect on July 1, 2050.

Provides that chapter 514E, relating to time shares, does not apply to a sale outside the United States of an interest in a time share unit in Hawaii if the unit is part of a time share plan that was previously registered in Hawaii. (SD1)
