## A BILL FOR AN ACT

RELATING TO STATE PLANNING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. During the 2005 Special Session, the
- 2 legislature adopted Act 8, which created the Hawaii 2050
- 3 sustainability task force (task force) to review the Hawaii
- 4 state plan and the State's planning process, and required the
- 5 office of the auditor to prepare the Hawaii 2050 Sustainability
- 6 Plan.
- 7 Once all of the members of the task force were appointed,
- 8 the task force held several meeting during the fall of 2005.
- 9 The objectives of these meetings were to address and meet the
- 10 requirements of Act 8 and to develop and approve a process to
- 11 create the Hawaii 2050 Sustainability Plan. Based on these
- 12 objectives, the task force submitted a report to the legislature
- 13 outlining the process for creating the plan and making
- 14 additional recommendations.
- In its recommendations, the task force noted that after
- 16 reviewing the magnitude of creating the sustainability plan,
- 17 more time is required to perform necessary research and
- 18 community outreach. The purpose of this Act is to extend:
