A BILL FOR AN ACT

RELATING TO HUMAN SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that it is critical to
- 2 achieve universal health coverage for Hawaii's residents.
- 3 Hawaii's QUEST program goes a long way toward this goal.
- 4 However, the program cannot handle all eligible uninsured
- 5 adults, and a cap has been placed on participation in the QUEST
- 6 program, thus leaving out tens of thousands of eligible
- 7 uninsured adults.
- 8 The current cap prevents many adults, especially
- 9 non-pregnant women, who are income- and asset-eligible from
- 10 enrolling in the program. These excluded but eligible adults
- 11 are at high risk for not getting necessary primary and
- 12 preventive care, not getting necessary prescription drugs, and
- 13 are more likely to incur or generate unnecessary emergency room
- 14 costs because of their uninsured status. Uninsured adults are a
- 15 financial burden on hospitals, emergency rooms, community health
- 16 care centers, and others that provide uncompensated care.
- 17 The legislature further finds that almost fifty-four per
- 18 cent of the funds needed to cover all eligible adults under the



- 1 QUEST program can be matched by the federal government. In
- 2 addition, the cap limit has not been raised even though more
- 3 children are now eligible due to more liberal eligibility
- 4 requirements for children implemented in July 2000.
- 5 The purpose of this Act is to expand enrollment in the
- 6 State's QUEST program by eliminating the enrollment cap.
- 7 SECTION 2. QUEST enrollment. The department of human
- 8 services shall submit a request to the Centers for Medicare and
- 9 Medicaid Services to amend the state waiver to allow the State
- 10 to remove its QUEST enrollment cap. Upon securing the amendment
- 11 to the state waiver, the department of human services shall
- 12 remove any cap on enrollment in the State's QUEST program and
- 13 shall enroll all otherwise eligible individuals. The director
- 14 of human services shall adopt rules in accordance with chapter
- 15 91 to implement this section.
- 16 SECTION 3. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$, or so
- 18 much thereof as may be necessary for fiscal year 2006-2007, for
- 19 expanding health care coverage by eliminating the cap on
- 20 enrollment in the State's QUEST program.
- 21 The sum appropriated shall be expended by the department of
- 22 human services for the purposes of this Act.

1 SECTION 4. This Act shall take effect on July 1, 2006.
