A BILL FOR AN ACT

RELATING TO LONG TERM CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The executive office on aging's long-term care 1 2 ombudsman program is mandated by the U.S. Administration on Aging through the Older Americans Act. The program provides 3 ombudsmen to advocate for and protect the rights of residents of 4 nursing homes, adult residential care homes, expanded adult 5 residential care homes, and assisted living facilities. 7 long-term care ombudsman program staff investigate and expedite resolution of residents' complaints statewide, on a confidential 8 9 basis.

The long-term care ombudsman program also provides information and referral assistance, conducts educational activities to increase community awareness of elder rights, advocates at the legislature, and provides training to long-term care staff, family councils and resident councils.

The program currently is staffed by two qualified ombudsman specialists who are charged with assuring advocacy and patient rights protection for an estimated eight thousand residents of the seven hundred thirty-one licensed facilities in Hawaii. In
