A BILL FOR AN ACT

RELATING TO COURT FEES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 571-83, Hawaii Revised Statutes, is 1 2 amended to read as follows: 3 "§571-83 Court and witness fees. In proceedings under 4 section 571-11(1) [and], (2), or (9), no court fees shall be charged against, and no witness fees shall be allowed to, any 5 6 party to a petition. No officer of the State or of any 7 political subdivision thereof shall be entitled to receive any 8 fee for the service of process or for attendance in court in any 9 such proceedings except as otherwise provided in this chapter. 10 All other persons acting under orders of the court may be paid 11 for service of process and attendance or service as witnesses, 12 the fees provided by law to be paid from the proper 13 appropriation when the allowances are certified to by the 14 judge." SECTION 2. Section 607-5, Hawaii Revised Statutes, is 15 16 amended by amending subsection (a) to read as follows: 17 The fees prescribed by the schedule in this section

shall be paid to the clerk of the circuit court as costs of

- 7 under chapter 333F or 334, or to small estates (including
- 8 decedents' estates and protection of property of minors and
- 9 persons under disability) when the amount payable is fixed by
- 10 another statute; and provided further that the fees prescribed
- 11 by subsection (c)(32) shall be deposited by the clerk of the

- 14 For the purpose of this section, "judgment" includes a

- In the application of this schedule, each case assigned a
