A BILL FOR AN ACT

RELATING TO HEALTH CARE PROFESSIONALS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a serious 2 crisis in medical and dental services in the neighbor islands, 3 particularly for the Med-QUEST and uninsured population. 4 growing crisis is due to the severe shortage of healthcare 5 providers. The increase in medical malpractice insurance 6 premiums in conjunction with salaries that are ten to twenty per 7 cent lower than on the mainland discourages healthcare 8 professionals from practicing medicine and dentistry in the 9 neighbor islands. Geographic isolation, lack of educational 10 opportunities for providers and their families, and low 11 reimbursement for medical services are other factors 12 contributing to the shortage. The legislature further finds 13 that an incentive program needs to be extended to healthcare 14 professionals to maximize the availability of quality healthcare 15 in the neighbor islands and encourage more healthcare 16 professionals to treat the Med-QUEST and uninsured population.
- 17 The purpose of this Act is to establish a tuition
 18 reimbursement program for University of Hawaii students and
