A BILL FOR AN ACT

RELATING TO PUBLIC ACCESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to amend the laws
- 2 that affect public access to coastal and inland areas. Part I
- 3 of this Act provides more protection to the public's right to
- have access to coastal and inland recreational areas and 4
- requires state and county agencies to ensure that a public 5
- 6 right-of-way is available for public use before approving a
- 7 development project, subdivision project, or zoning initiative
- that may affect public access. Part II of this Act clarifies 8
- the definition of inland public recreational areas and provides 9
- 10 specific prohibitions for obstructing public access in coastal
- 11 and inland areas.
