### A BILL FOR AN ACT

RELATING TO EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature found that civil service
2	employees of the department of education schools should not lose
3	civil service status, rights, and benefits upon conversion of
4	their schools to new century conversion charter schools. In
5	order to preserve the civil service status, rights, and benefits
6	of the department of education employees transferred to the new
7	century conversion charter schools and those hired after
8	conversion to new century conversion charter schools, the
9	legislature granted civil service status to the employees when
10	it enacted Act 63, Session Laws of Hawaii 2004.
11	The legislature also enacted Act 51, Session Laws of Hawaii
12	2004, which separated the department of education civil service
13	employees from the department of human resources and development
14	authority to reduce bureaucracy. In contrast, the new century
15	conversion charter school civil service employees were deemed,
16	under Act 51, to be under the authority of the department of

human resources development.

It was not, however, the intent of the legislature with the 1 enactment of Act 63, Session Laws of Hawaii 2004, and Act 51, 2 Session Laws of Hawaii 2004, to deprive these civil service 3 employees of the new century conversion charter schools the 4 5 opportunity to be considered for transfers and promotions to 6 other department of education schools. If the civil service employees of the new century conversion charter schools remain 7 under the authority of the department of human resources 8 development, these employees cannot be considered for lateral 9 10 transfers and promotions as similar civil service employees of 11 the department of education. The purpose of this Act is to preserve the rights, 12 privileges, and benefits of the civil service employees of the 13 new century conversion charter schools by permitting the civil 14 service employees to remain within the department of education 15 16 human resources system. SECTION 2. Section 302A-1184, Hawaii Revised Statutes, is 17 amended by amending subsection (b) to read as follows: 18 "(b) Civil service employees of department of education 19 schools shall retain their civil service status upon the 20 21 conversion of their school to a new century conversion charter

### Description:

Confers the same rights and benefits of civil service employees in the department of education to civil service employees of the new conversion charter schools.
