SECTION 1. Section 92F-12, Hawaii Revised Statutes, is 1 amended by amending subsection (a) to read as follows: 2 Any other provision in this chapter to the contrary 3 notwithstanding, each agency shall make available for public 4 inspection and duplication during regular business hours: 5 Rules of procedure, substantive rules of general (1)6 applicability, statements of general policy, and 7 interpretations of general applicability adopted by 8 the agency; 9 Final opinions, including concurring and dissenting (2) 10 opinions, as well as orders made in the adjudication 11 of cases, except to the extent protected by section 12 92F-13(1); 13 Government purchasing information, including all bid (3) 14 results, except to the extent prohibited by section 15 92F-13; 16
