### A BILL FOR AN ACT

RELATING TO CORRECTIONS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

Section 352-5, Hawaii Revised Statutes, is 4 5 amended to read as follows: 6 "\$352-5 Staff standards and training. The director shall 7 establish written standards of conduct and operation to govern 8 each staff member during working hours. Standards shall include 9 a sick leave policy and protocols regarding suicide prevention, 10 proper use of force, substance abuse, mental health issues, and 11 rehabilitation of persons committed to a facility. New staff 12 members shall undergo initial training to prepare them to comply 13 with the standards. Attendance at periodic training sessions shall be mandatory to increase staff members' effectiveness in 14 15 carrying out their duties. For purposes of this section, "staff member" means any employee of the Hawaii youth correctional 16 facilities who is directly involved with the treatment and care **17** 18 of persons committed to a facility." 19 SECTION 3. Section 352-13, Hawaii Revised Statutes, is 20 amended to read as follows: 21 "\$352-13 Evaluation, counseling, training. The director 22 shall provide the opportunity for intelligence and aptitude

evaluation, psychological testing and counseling, prevocational 1 and vocational training, and employment counseling to all 2 persons committed to the youth correctional facilities. 3 4 Counseling services shall be available for the committed person's family including a reciprocal beneficiary, during the 5 6 term of commitment. The director shall develop and implement a 7 program to: 8 (1)Provide a comprehensive medical, mental, developmental, and social evaluation of all committed 9 10 persons; 11 (2) Create an individualized treatment plan for each 12 committed person; 13 Develop and implement teams as necessary to carry out (3) 14 the individualized treatment plans; and 15 (4)Develop appropriate programs to meet the needs of committed persons." 16 17 SECTION 4. Section 352D-9, Hawaii Revised Statutes, is 18 amended to read as follows: 19 "[+]\$352D-9[+] Office of youth services regional advisory 20 boards; power, duties, and authority. (a) There shall be 21 established a regional advisory board located in each county and

- 2 support for each board. Each board shall elect annually from
- 3 among its members a chairperson who shall preside at its regular
- 4 meetings. Each board shall be composed of eleven voting
- 5 members. Each board's membership shall include four lay
- 6 persons, of which two shall possess knowledge of youth services,
- 7 all appointed by the governor as provided in section 26-34[-];
- 8 provided that two persons shall be selected from a list of four
- 9 names jointly compiled by the speaker of the house of
- 10 representatives and the president of the senate.
- 11 The Oahu regional advisory board shall include the
- 12 superintendent of education, the public defender, the directors
- 13 of human services and health, the police chief and the
- 14 prosecuting attorney of the city and county of Honolulu, and the
- 15 senior family court judge of the first circuit, or their
- 16 designees.
- 17 The other regional advisory boards shall include the
- 18 county's chief of police and prosecuting attorney, a deputy
- 19 public defender, a family court judge, and one representative
- 20 each from the departments of education, human services, and
- 21 health, who shall be selected by their respective directors, or
- 22 their designees.

- 1 All board members shall be residents of the county in which 2 the regional advisory board to which they are appointed is 3 located, and shall serve without compensation, but shall be 4 reimbursed for necessary expenses incurred during the 5 performance of their duties. 6 Each regional board shall have the responsibility of 7 investigating and reporting misfeasance and malfeasance, 8 inquiring into areas of concern, and conducting periodic audit 9 evaluations of youth correctional facilities within its region 10 to ascertain their effectiveness and compliance with established 11 responsibilities. Each regional board shall have the authority 12 to examine all records and budgets pertaining to youth 13 correctional facilities within its region, and shall have access 14 to youth correctional facilities within its region for the 15 purpose of conducting site visits and speaking with persons 16 committed to the facilities and staff members. **17** [\(\frac{\dagger}{\dagger}\)] (c) There shall be a combined meeting of all boards at least once a year. Each regional board shall advise the 18 19 office on:
- (1) General policies relating to the youth service system, 21 including but not limited to planning, integration,
