A BILL FOR AN ACT

RELATING TO DENTISTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a severe
- 2 shortage of dental services in the underserved communities of
- 3 Hawaii, particularly with Med-QUEST and uninsured patients.
- 4 This growing crisis is due to geographic isolation, lack of
- 5 educational opportunities for dentists and their families, and
- 6 salaries that are up to twenty per cent lower than on the
- 7 mainland.
- 8 The legislature further finds that dental health is
- 9 paramount in the overall health and well-being of the citizens
- 10 of Hawaii and that an incentive program needs to be established
- 11 to maximize the availability of quality dental care in
- 12 underserved communities. The dental care student loan repayment
- 13 program will advance this purpose by enabling dentists who are
- 14 already licensed and experienced to fill the immediate need
- 15 while alleviating the huge financial burden that professional
- 16 education imposes on dentists.
- 17 The purpose of this Act is to establish a student loan
- 18 repayment program as an incentive for dentists who serve in

1 underserved communities and accept medicaid and uninsured 2 patients. 3 SECTION 2. Chapter 321, Hawaii Revised Statutes, is 4 amended by adding a new section to be appropriately designated 5 and to read as follows: 6 Dental care student loan repayment program; 7 establishment. (a) There is established within the department 8 of health a dental care student loan repayment program to be 9 administered by the director of health. The program shall 10 provide student loan repayment to dentists in exchange for 11 service in an underserved community in Hawaii as provided for in subsection (b). 12 13 (b) Pursuant to this program, the department shall award a 14 dentist one year of educational loan repayment annually in 15 exchange for every two years that the dentist agrees to practice 16 in a state-designated dental health professional shortage area **17** and up to a maximum of three years of loan repayment; provided 18 that the dental professional: 19 (1) Is licensed to practice dentistry under chapter 448; 20 and

Meets at least one of the following criteria:

16	section.	The	rules shall address the following:

13	SECT	ION 4. The sum appropriated shall be expended by the			
14	departmen	t of health for the purposes of this Act.
