A BILL FOR AN ACT

RELATING TO EMERGENCY RELIEF FOR NATURAL DISASTERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Residents and businesses of the State are often
- 2 twice victimized when natural disasters strike. First, the
- 3 damage caused by a natural disaster is often extensive and
- 4 repair or replacement costs are prohibitive. Second, the
- 5 emergency relief from governmental agencies to meet the
- 6 immediate needs of victims is often delayed or unavailable for
- 7 extended periods. For some victims of natural disasters, the
- 8 delay in receiving emergency assistance can mean a total loss of
- 9 their homes or businesses. The legislature finds that there is
- 10 an urgent need to provide victims with prompt emergency relief
- 11 during or immediately after a natural disaster.
- 12 The purpose of this Act is to allow the governor, upon the
- 13 declaration of an emergency, to release up to ten per cent of
- 14 the moneys appropriated from the emergency and budget reserve
- 15 fund to provide assistance to residents and businesses that have
- 16 sustained damage during or immediately after a natural disaster.
- 17 SECTION 2. Section 328L-3, Hawaii Revised Statutes, is
- 18 amended to read as follows:

of the expenditures consistent with subsection (d), the amounts, 1 2 and the reasons justifying the necessity for the appropriations. 3 The legislature may make appropriations from the fund 4 for the following purposes: To maintain levels of programs determined to be 5 (1)essential to public health, safety, welfare, and 6 education; 7 To provide for counter cyclical economic and 8 (2) employment programs in periods of economic downturn; 9 10 (3) To restore facilities destroyed or damaged or services 11 disrupted by disaster in any county; and To meet other emergencies when declared by the (4)12 governor or determined to be urgent by the 13 legislature. 14 15 Any act making appropriations from the emergency and budget reserve fund shall include a declaration of findings and 16 17 purposes setting forth the purposes, the amounts, and the 18 reasons why the appropriations are necessary and, except as 19 provided in subsection (e), shall require a two-thirds majority vote of each house of the legislature. 20

(e) Upon the declaration by the governor of an emergency

due to a natural disaster, the governor, by executive order, may

9	subsection (d) for which the funds were released;
10	(C) Explain the factors that necessitated the use of
11	moneys in the fund; and
12	(D) Provide recommendations for replacing the
13	expended moneys from the fund.
14	$[\frac{(e)}{(e)}]$ Appropriations for the following purposes from
15	the emergency and budget reserve fund are specifically
16	prohibited:
17	(1) To meet expenses of the legislature;
18	(2) To provide for salary adjustments for officials
19	appointed pursuant to article V, section 6, or article
20	VI, section $3_{\underline{\prime}}$ of the Constitution of the State of
21	Hawaii and for others whose salaries are directly
22	related to salaries of these officials; and

- To fund cost items in any collective bargaining 1 (3) contract." 2 SECTION 3. There is appropriated out of the general 3
- revenues of the State of Hawaii the sum of \$ 4 , or so
- much thereof as may be necessary for fiscal year 2006-2007, to 5
- carry out the purposes of section 328L-3, Hawaii Revised
- Statutes. 7
- SECTION 4. The sum appropriated shall be expended by the 8
- 9 director of finance for the purposes of this Act.

SECTION 5. This Act shall take effect on July 1, 2006. 10
