# A BILL FOR AN ACT

RELATING TO EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act shall be known as the "Fix Our Schools
- 2 Act of 2006."
- 3 SECTION 2. The legislature finds that Hawaii's future
- 4 depends on our youth, and the investments we make in our young
- 5 people today will determine the course of our state in the years
- 6 to come. One of the greatest investments we can make is to
- 7 provide our youth with the best possible opportunities in
- 8 education.
- 9 It has been proven that a proper scholastic environment--
- 10 one that is safe, secure, well-maintained, and clean--is a key
- 11 contributor to a child's capacity to learn.
- 12 However, the legislature finds that there is a continuing
- 13 backlog of repair and maintenance projects for Hawaii's public
- 14 schools. In 2001, the Hawaii Opinion Poll on Public Education
- 15 found that rundown, poorly kept, or inadequate facilities ranked
- 16 third in the ten biggest problems facing our schools. Student
- 17 leaders at the 2005 Hawaii Secondary Student Conference passed a



- 1 resolution supporting the expenditure of funds to relieve the
- 2 backlog.
- 3 Hence, the purpose of this Act is to provide resources for
- 4 the repair, maintenance, and renovation of Hawaii's public
- 5 schools.
- 6 SECTION 3. In accordance with section 9 of article VII, of
- 7 the Constitution of the State of Hawaii and sections 37-91 and
- 8 37-93, Hawaii Revised Statutes, the legislature has determined
- 9 that the appropriations contained in this Act will cause the
- 10 state general fund expenditure ceiling for fiscal year 2006-2007
- 11 to be exceeded by \$111,841,598 or 2.1 per cent. The reasons for
- 12 exceeding the general fund expenditure ceiling are that the
- 13 appropriations made in this Act are necessary to serve the
- 14 public interest and to meet the needs provided for by this Act.
- 15 SECTION 4. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$160,000,000 or so
- 17 much thereof as may be necessary for fiscal year 2006-2007 for
- 18 the renovation of classrooms statewide in the department of
- 19 education.
- The appropriation made by this section shall not lapse at
- 21 the end of the fiscal year for which the appropriation is made;

- 1 provided that all moneys from the appropriation unencumbered as
- 2 of June 30, 2008, shall lapse as of that date.
- 3 The sum appropriated shall be expended by the department of
- 4 education for the purposes of this section.
- 5 SECTION 5. The director of finance is authorized to issue
- 6 general obligation bonds in the sum of \$40,000,000 or so much
- 7 thereof as may be necessary, and the same sum or so much thereof
- 8 as may be necessary is appropriated for fiscal year 2006-2007
- 9 for repair and maintenance of department of education school
- 10 facilities.
- 11 The appropriation made by this section shall not lapse at
- 12 the end of the fiscal year for which the appropriation is made;
- 13 provided that all moneys from the appropriation unencumbered as
- 14 of June 30, 2008, shall lapse as of that date.
- The appropriation made by this section shall be deposited
- 16 in the state educational facilities special fund.
- 17 The sum appropriated shall be expended by the department of
- 18 education for the purposes of this section.
- 19 SECTION 6. There is appropriated out of the state
- 20 educational facilities special fund the sum of \$40,000,000 or so
- 21 much thereof as may be necessary for fiscal year 2006-2007 for

- 1 the repair and maintenance of department of education school
- 2 facilities.
- 3 The sum appropriated shall be expended by the department of
- 4 education for the purposes of this section.
- 5 SECTION 7. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$35,000,000 or so
- 7 much thereof as may be necessary for fiscal year 2006-2007 for
- 8 repair and maintenance of department of education school
- 9 facilities.
- 10 The appropriation made by this section shall not lapse at
- 11 the end of the fiscal year for which the appropriation is made;
- 12 provided that all moneys from the appropriation unencumbered as
- 13 of June 30, 2008, shall lapse as of that date.
- 14 The sum appropriated shall be expended by the department of
- 15 education for the purposes of this section.
- 16 SECTION 8. This Act shall take effect on July 1, 2006.
