A BILL FOR AN ACT

RELATING TO THE STATE PHARMACY ASSISTANCE PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 346-341, Hawaii Revised Statutes, is amended by repealing the definition of "asset test." 2 3 [""Asset test" means the asset limits for eligibility in 4 the state pharmacy assistance program as defined by the Medicare 5 Modernization Act and any amendments thereto."] 6 SECTION 2. Section 346-341, Hawaii Revised Statutes, is 7 amended by repealing the definition of "full coverage 8 prescription drug benefit." 9 [""Full coverage prescription drug benefit" means a 10 federally approved prescription drug plan that offers a zero 11 co-payment benefit for medicaid dual eligibles under the 12 medicare part D drug benefit."] 13 SECTION 3. Section 346-341, Hawaii Revised Statutes, is 14 amended by repealing the definition of "liquid assets." 15 [""Liquid assets" means assets used in the eligibility 16 determination process as defined by the Medicare Modernization 17 Act."]

1 SECTION 4. Section 346-342, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "[+] §346-342[+] State pharmacy assistance program. 4 There is established within the department the state pharmacy 5 assistance program. Provided that there are no federally 6 approved prescription drug plans available in the State that 7 provide a full coverage prescription drug benefit, the state 8 pharmacy assistance program may coordinate the prescription drug 9 coverage with the federal medicare part D prescription drug 10 benefit, including related supplies, as determined by the 11 department, to each resident who meets the eligibility 12 requirements as outlined in section 346-343. 13 The department [may] shall provide enrollment assistance to eligible individuals [into the state pharmacy 14 assistance program. Enrollment for medicaid dual eligible 15 16 persons shall begin no later than October 1, 2005. to identify 17 the medicare prescription drug plans that best meet the needs of 18 the enrollee at the lowest cost, based on the enrollee's 19 medication, pharmacy, and overall costs to the enrollee, and to 20 assist the enrollee in joining or changing plans. 21 The department shall allow any willing prescription

drug plan approved by the federal Centers for Medicare and

- 1 Medicaid Services to provide the coordination of benefits
- 2 between the State's medicare prescription drug program and the
- 3 medicare part D drug benefit.
- 4 (d) The department may administer the state pharmacy
- 5 assistance program or contract with a third party or parties in
- 6 accordance with chapter 103F to administer any single component
- 7 or combination of components of the state pharmacy assistance
- 8 program, including outreach, eligibility, enrollment, claims,
- 9 administration, rebate negotiations and recovery, and
- 10 redistribution, in order to coordinate the prescription drug
- 11 benefits of the state pharmacy assistance program and the
- 12 federal medicare part D drug benefit.
- (e) Any contract with third parties to administer any
- 14 component of the state pharmacy assistance program shall be
- 15 established either at no cost to the State, or on a
- 16 contingency-fee basis and with no up-front costs to the State,
- 17 as may be negotiated by the department.
- 18 (f) Any contract with third parties to administer any
- 19 component of the state pharmacy assistance program shall
- 20 prohibit the contractor from receiving any compensation or other
- 21 benefits from any pharmaceutical manufacturer participating in
- 22 the state pharmacy assistance program.

- 1 (g) A prescription drug manufacturer or labeler that sells
- 2 prescription drugs in the State may enter into a rebate
- 3 agreement with the department [-]; provided that it does not
- 4 conflict with federal law. The rebate agreement may be agreed
- 5 upon by the manufacturer or the labeler to make rebate payments
- 6 to the department each calendar quarter or according to a
- 7 schedule established by the department.
- 8 (h) The department or contractor may negotiate the amount
- 9 of the rebate required from a manufacturer or labeler in
- 10 accordance with this part.
- 11 (i) The department or contractor may take into
- 12 consideration the rebate calculated under the medicaid rebate
- 13 program pursuant to Title 42 United States Code Section 1396r-8,
- 14 the average wholesale price of prescription drugs, and any other
- 15 cost data related to prescription drug prices and price
- 16 discounts.
- 17 (j) The department or contractor shall use their best
- 18 efforts to obtain the best possible rebate amount.
- 19 (k) The department may prescribe the application and
- 20 enrollment procedures for prospective enrollees.

- 19 coverage, and formulary exceptions."
- 20 SECTION 6. Section 346-344, Hawaii Revised Statutes, is

1	alternative medications available from the medicare
2	prescription drug plan would be less effective than
3	the prescribed medication or unsafe. The department
4	is authorized to seek reimbursement from the medicare
5	prescription drug plan and to request and appeal a
6	part D formulary exception on behalf of the department
7	and the beneficiary.
8	(b) The state pharmacy assistance program is the payor of
9	last [resort, subject to receipt of sufficient rebates pursuant
10	to section 346 342(g), as determined by the department.] resort
11	(c) The state pharmacy assistance program shall be funded
12	with state appropriations, including funds derived from revenues
13	to the State from rebates paid by pharmaceutical manufacturers
14	pursuant to section 346-342(g), [which may affect the level of
15	benefits to program enrollees pursuant to subsection (a)
16	depending on the amount of the rebates received by the State to
17	cover all program benefits and costs of administering the
18	program.] and with savings resulting from medicare prescription
19	drug coverage for the medicaid dual eligible population."
20	SECTION 7. Section 346-345, Hawaii Revised Statutes, is
21	amended by amending subsection (b) to read as follows:
