## A BILL FOR AN ACT

RELATING TO INVASIVE SPECIES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 150A, Hawaii Revised Statutes, is
- amended by adding two new sections to be appropriately 2
- 3 designated and to read as follows:
- 4 "\$150A-A Inspection, quarantine, and eradication service
- 5 charge. (a) The department shall prescribe and collect a
- 6 schedule of service fees and charges for invasive species
- 7 inspection, quarantine, and eradication services from any person
- who imports any article or means of conveyance. The department 8
- 9 shall establish a schedule of service fees and charges to ensure
- that the service is commensurate with the costs of inspection, 10
- 11 quarantine, and eradication services.
- 12 (b) Any person who imports an article or means of
- 13 conveyance shall pay the appropriate service fee or charge to
- the department before the article or means of conveyance is 14
- 15 moved from a port of entry in the State.
- 16 (c) If a person subject to a service fee or charge under
- 17 this section fails to pay the service fee or charge when due,
- 18 the department shall assess a late payment penalty.

- 2 amended by adding two new definitions to be appropriately
- 3 inserted and to read as follows:
- 4 ""Article" means any material or tangible object that could
- 5 harbor invasive species, including plants, plant products, soil,
- 6 boxes and containers, vehicles, baggage, or packing material
- 7 used in connection with the movement of plants, plant products,
- 8 or animals.
- 9 "Means of conveyance" means any personal property used for
- 10 or intended for use for the movement of any other personal
- 11 property."
- 12 SECTION 3. In codifying the new sections added by section
- 13 1 of this Act, the revisor of statutes shall substitute
- 14 appropriate section numbers for the letters used in designating
- 15 the new sections in this Act.
- 16 SECTION 4. New statutory material is underscored.
- 17 SECTION 5. This Act shall take effect on July 1, 2006.
