A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYEES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 89-9, Hawaii Revised Statutes, is 2 amended as follows: 3 By amending subsection (d) to read as follows: "(d) Excluded from the subjects of negotiations are 4 matters of classification, reclassification, benefits of but not 5 6 contributions to the Hawaii employer-union health benefits trust 7 fund or a voluntary employees' beneficiary association trust; 8 recruitment; examination; initial pricing; and retirement 9 benefits except as provided in section 88-8(h). The employer 10 and the exclusive representative shall not agree to any proposal that would be inconsistent with the merit principle or the 11 12 principle of equal pay for equal work pursuant to section 76-1 13 or that would interfere with the rights and obligations of a 14 public employer to: 15 (1) Direct employees; 16 (2) Determine qualifications, standards for work, and the

nature and contents of examinations;

- 5 Violations of the procedures so negotiated may be subject to the
- 6 grievance procedure in the collective bargaining agreement."
- 7 2. By amending subsection (f) to read as follows:
- 8 "(f) The repricing of classes within an appropriate
- 9 bargaining unit may be negotiated as follows:
- 10 (1) At the request of the exclusive representative and at
- 11 times allowed under the collective bargaining
- agreement, the employer shall negotiate the repricing
- of classes within the bargaining unit. The negotiated
- 14 repricing actions that constitute cost items shall be
- subject to the requirements in section 89-10 [-]; and
- 16 (2) If repricing has not been negotiated under paragraph
- 17 (1), the employer of each jurisdiction shall ensure
- 18 establishment of procedures to periodically review, at
- 19 least once in five years, unless otherwise agreed to
- 20 by the parties, the repricing of classes within the
- 21 bargaining unit. The repricing of classes based on
- the results of the periodic review shall be at the

1	discretion of the employer. Any appropriations
2	required to implement the repricing actions that are
3	made at the employer's discretion shall not be
4	construed as cost items."
