A BILL FOR AN ACT

RELATING TO STUDENTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there are many
- 2 benefits to a reduction in the student-teacher ratio. There are
- 3 approximately twelve thousand teachers and 183,000 students in
- 4 the public school system, which translates to a student-teacher
- 5 ratio of 15.25-to-one.
- 6 The legislature also finds that both teachers and students
- 7 benefit from smaller class sizes, as well as having support from
- 8 other teachers in specialty areas such as art, music, physical
- 9 education, gifted and talented, technology, and others, and
- 10 support from tutors, counselors, librarians, and other staff
- 11 members.
- In order to lower the student-teacher ratio of 15.25-to-one
- 13 to a targeted 14.75-to-one, an additional four hundred six
- 14 teachers would need to be hired. The result would be an average
- 15 increase of one teacher per school of four hundred fifty
- 16 students, or four additional teachers per school of one thousand
- 17 eight hundred students.



1	SECT	ION 2. Chapter 302A, Hawaii Revised Statutes, is
2	amended b	y adding a new section to be appropriately designated
3	and to read as follows:	
4	" <u>§30</u>	2A- Reduction of student-teacher ratio. (a)
5	Subject t	o the availability of funds appropriated by the
6	legislature and allotted by the governor, the department:	
7	(1)	Shall reduce the ratio of students to teachers in
8		elementary school grades one to five to not more than
9		students to one teacher;
10	(2)	Shall reduce the ratio of students to teachers in
11		middle school grades six to eight to not more than
12		students to one teacher; and
13	(3)	Shall reduce the ratio of students to teachers in high
14		schools grades nine to twelve to not more than
15		students to one teacher.
16	<u>(b)</u>	Subject to the availability of funds appropriated by
17	the legis	lature and allotted by the governor, the department
18	shall sup	port class size reduction by providing additional staff
19	as necessary, including teachers from art, music, physical	
20	education, gifted and talented, technology, and other specialty	
21	areas, tutors, counselors, librarians, and other staff as	
22	appropriate."	

- 1 SECTION 3. The department of education shall plan and
- 2 budget for future staffing needs and construction to accommodate
- 3 the reduction of the student-teacher ratio at all grade levels.
- 4 The department shall report to the legislature no later than
- 5 twenty days prior to the convening of the regular session of
- 6 2007, on its plan, timetable, and budgetary projections to
- 7 accomplish the purposes of this Act.
- 8 SECTION 4. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$, or so
- 10 much thereof as may be necessary for fiscal year 2006-2007, to
- 11 phase in the reduction of class size in all public elementary,
- 12 middle, and high school grades over the next three years
- 13 beginning with school year 2006-2007, including the hiring of
- 14 additional teachers, tutors, counselors, librarians, resource
- 15 teachers, and other staff as necessary for the purposes of this
- 16 Act.
- 17 SECTION 5. The sum appropriated shall be expended by the
- 18 department of education for the purposes of this Act.
- 19 SECTION 6. New statutory material is underscored.
- 20 SECTION 7. This Act shall take effect on July 1, 2006.
