## A BILL FOR AN ACT

RELATING TO BEACH DEBRIS REMOVAL.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 26-15, Hawaii Revised Statutes, is 2 amended to read as follows:
- 3 "\$26-15 Department of land and natural resources. (a)
- 4 The department of land and natural resources shall be headed by
- 5 an executive board to be known as the board of land and natural
- 6 resources, except for matters relating to the state water code
- 7 where the commission on water resource management shall have
- 8 exclusive jurisdiction and final authority.
- 9 The board shall consist of seven members, one from each
- 10 land district and three at large. The appointment, tenure, and
- 11 removal of the members and the filling of vacancies on the board
- 12 shall be as provided in section 26-34. At least one member of
- 13 the board shall have a background in conservation and natural
- 14 resources, as provided in section 171-4.
- 15 The governor shall appoint the chairperson of the board
- 16 from among the members thereof.

1 The board may delegate to the chairperson such duties, 2 powers, and authority, or so much thereof, as may be lawful or proper for the performance of the functions vested in the board. 3 4 The chairperson of the board shall serve in a full-time 5 capacity.
