## A BILL FOR AN ACT

RELATING TO HAWAIIAN HOME LANDS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 213.6 of the Hawaiian Homes Commission
- 2 Act, 1920, as amended, is amended to read as follows:
- 3 "[+] §213.6.[+] Hawaiian home lands trust fund. There is
- 4 established in the treasury of the State a trust fund to be
- 5 known as the Hawaiian home lands trust fund, into which shall be
- 6 deposited all appropriations by the State legislature specified
- 7 to be deposited therein. Moneys of the Hawaiian home lands
- 8 trust fund shall be expended by the department as provided by
- 9 law upon approval by the commission and shall be used for
- 10 capital improvements and other purposes undertaken in
- 11 furtherance of the Act. The department shall have fiduciary
- 12 responsibility toward the trust fund, and shall provide annual
- 13 reports therefor to the legislature and to the beneficiaries of
- 14 the trust.
- The commission may deposit moneys from the trust fund into
- 16 depositories other than the state treasury and may manage,
- 17 invest, and reinvest moneys in the trust fund. The commission
- 18 may hold, purchase, sell, assign, transfer, or dispose of any



1	securities and investments in which any of the moneys have been
2	invested, as well as the proceeds of the investments. Any
3	interest or other earnings arising out of investments from the
4	trust fund shall be credited to and deposited into the trust
5	fund."
6	SECTION 2. The provisions of the amendments made by this
7	Act to the Hawaiian Homes Commission Act, 1920, as amended, are
8	declared to be severable, and if any section, sentence, clause,
9	or phrase, or the application thereof to any person or
10	circumstances is held ineffective because there is a requirement
11	of having the consent of the United States to take effect, then
12	that portion only shall take effect upon the granting of consent
13	by the United States and effectiveness of the remainder of these
14	amendments or the application thereof shall not be affected.
15	SECTION 3. Statutory material to be repealed is bracketed
16	and stricken. New statutory material is underscored.

## Report Title:

Hawaiian Homes Commission; Deposit and Investment of Funds

## Description:

Allows the Hawaiian homes commission to deposit moneys in depositories other than the state treasury. Authorizes the Hawaiian homes commission to manage, invest, and reinvest moneys in the trust fund. Authorizes the commission to hold, purchase, sell, assign, transfer, or dispose of any securities and investments and any proceeds from investments in which trust fund moneys have been invested.
