A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature recognizes that, according to 1 the national center for public policy and higher education, net 2 college costs for low- and middle-income students to attend 3 Hawaii's public four-year colleges and universities represent a 4 third of their families' annual income. In 2004, the national 5 non-profit independent organization gave Hawaii a "D" for 6 affordability. The organization also noted that "over the past 7 few years, Hawaii has had among the steepest declines in the 8 nation in the percentage of first-time, full-time college 9 students earning their bachelor's degree within six years of 10 enrolling in college." 11 During the 2005 legislative session, recognizing the need 12 to provide financial support to Hawaii's residents in attaining 13 a post secondary degree, the legislature appropriated \$1,500,000 14 in general funds for the fiscal biennium 2005-2007 to provide 15 merit-based scholarships for Hawaii's low-income public school 16 graduates wishing to attend the University of Hawaii. Despite 17 this appropriation, the legislature finds that the increases in 18

- 1 the tuition and fee schedule, which take effect in the fall of
- 2 2006, will continue to make it difficult for Hawaii's residents
- 3 to attend the university. The legislature also finds that the
- 4 initial appropriation of \$1,500,000 is not sufficient to enroll
- 5 a significant proportion of the estimated number of eligible
- 6 applicants.
- 7 Given the State's current financial surplus, and based on
- 8 input from the university, the purpose of this Act is to
- 9 encourage Hawaii residents to pursue post secondary school
- 10 education by:
- 11 (1) Amending section 57 of Act 178, Session Laws of Hawaii
- 12 2005, to clarify the financial eligibility guidelines;
- (2) Establishing a workforce development scholarship
- program at the community colleges based on need;
- 15 (3) Establishing the Hawaii state scholars program; and
- 16 (4) Placing funds for all scholarship programs in a
- 17 separate account in the student scholarship and
- 18 assistance special fund.
- 19 SECTION 2. Chapter 304, Hawaii Revised Statutes, is
- 20 amended by adding a new section to be appropriately designated
- 21 and to read as follows:

2	established the Hawaii state scholars program to be administered			
3	by the University of Hawaii. This program shall be used to			
4	provide financial assistance in the form of scholarships for up			
5	to four years to any qualified student enrolled at any campus of			
6	the University of Hawaii with the possibility of renewal for a			
7	fifth year in exceptional circumstances.			
8	(b) Appropriations for the state scholars program shall be			
9	deposited into the University of Hawaii student scholarship and			
10	assistance special fund established pursuant to section			
11	304-16.6. The number of scholarships awarded and amount of each			
12	scholarship shall be determined by the university subject to the			
13	availability of funds.			
14	The University of Hawaii shall offer scholarships to pay			
15	for educational costs, such as tuition, fees, books, housing,			
16	and other educational costs; provided that the scholarship			
17	applicant:			
18	(1) Is a bona fide resident of the State, for tuition			
19	purposes, at the time of admission to the university;			
20	(2) Presents evidence of academic excellence by meeting			
21	one or more of the following:			

1	<u>(A)</u>	Graduation from a public or private high school
2		in the State as a valedictorian of the
3		applicant's class;
4	<u>(B)</u>	Has a cumulative high school grade point average
5		of 4.0 as determined for admission to the
6		university; or

8		college admission test recognized and accepted by
9		the university for admission consideration, such
10		as SAT or ACT, that places the student among the
11		top ten percentile of students taking the test

13	<u>(3)</u> <u>En</u>	colls at a University of Hawaii system campus within
14	eig	ghteen months of graduating from high school; and
15	<u>(4)</u> <u>Mai</u>	intains satisfactory progress toward degree
16	con	mpletion and a cumulative 3.0 grade point average."
17	SECTION	3. Chapter 305, Hawaii Revised Statutes, is
18	amended by ac	dding a new section to be appropriately designated
19	and to read a	as follows:
20	" <u>§305-</u>	Workforce development scholarship program. (a)
21	There is esta	ablished the workforce development scholarship
22	program to be	e administered by the University of Hawaii to

- 1 address projected shortfalls in and needs of the workforce. The
- 2 program shall be used to provide financial assistance for up to
- 3 three years to any qualified student enrolled at a community
- 4 college campus of the University of Hawaii.
- 5 (b) The number of scholarships awarded and the amount of
- 6 each scholarship shall be determined by the university and shall
- 7 be subject to the availability of funds. The University of
- 8 Hawaii shall offer scholarships to pay for educational costs,
- 9 such as tuition, fees, books, housing, and other educational
- 10 costs; provided that the scholarship applicant:
- 11 (1) Qualifies for Hawaii resident tuition;
- (2) Earned a high school diploma or passed the general
- 13 educational development test; and
- 14 (3) Is eligible for need-based aid according to federal
- financial aid guidelines.
- 16 The scholarship may be renewed annually for up to three years;
- 17 provided that the student maintains satisfactory academic
- 18 progress."
- 19 SECTION 4. Section 304-16.6, Hawaii Revised Statutes, is
- 20 amended by amending subsection (b) to read as follows:
- 21 "(b) Revenues deposited into this fund shall include but
- 22 not be limited to state, federal, and private funds, [and] funds

- 1 transferred by the university from the tuition and fees special
- 2 fund pursuant to section $304-16.5[\div]$, and appropriations for the
- 3 state scholars program; provided that state funds appropriated
- 4 for any scholarship program, including but not limited to the B
- 5 Plus scholarship program, the Hawaii state scholars program, and
- 6 the workforce development scholarship program, shall be kept in
- 7 a separate and distinct account."
- 8 SECTION 5. Act 178, Session Laws of Hawaii 2005, is
- 9 amended by amending section 57 to read as follows:
- 10 "SECTION 57. Provided that of the general fund
- 11 appropriation for the University of Hawaii systemwide (UOH 900),
- 12 the sum of \$500,000 or so much thereof as may be necessary for
- 13 fiscal year $2005-2006[_{7}]$ and the sum of \$1,000,000 or so much
- 14 thereof as may be necessary for fiscal year $2006-2007[\tau]$;
- 15 provided further that the amounts shall be used to fund the [B-
- 16 Plus Scholarship B Plus scholarship program; provided further
- 17 that the university shall offer [full] scholarships to any
- 18 Hawaii resident [applying to] who:
- 19 (1) Enrolls in any campus within the university system
- 20 [provided that the individual has];
- 21 (2) Has graduated from a Hawaii public high school with a
- cumulative grade point average of 3.0 or better; and

1	[is considered low income according to the state of
2	Hawaii department of education's guidelines for
3	students qualifying for the free and reduced lunch
4	program.]
5	(3) Is eligible for need-based financial aid based on
6	federal financial aid guidelines;
7	and provided further that the scholarship may be renewed
8	annually if the student maintains satisfactory academic progress
9	and continues to meet financial aid guidelines."
10	SECTION 6. The university of Hawaii shall transfer the sum
11	of \$500,000, or so much thereof as may be necessary for fiscal
12	year 2006-2007, from the University of Hawaii tuition and fees
13	special fund for deposit into the student scholarship and
14	assistance special fund for the purposes of funding the
15	workforce development scholarship program.
16	The sum transferred shall be expended by the University of
17	Hawaii for the purposes of this Act.
18	SECTION 7. Statutory material to be repealed is bracketed
19	and stricken. New statutory material is underscored.
20	SECTION 8. This Act shall take effect on July 1, 2006.
