## A BILL FOR AN ACT

RELATING TO NURSE AIDES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature recognizes that 42 United
- 2 States Code sections 1395i-3 and 1396R require nurse aides
- 3 working in nursing facilities participating in medicare and
- 4 medicaid programs to be certified.
- 5 The purpose of this Act is to require all practicing nurse
- 6 aides, working in state licensed or state certified health care
- 7 settings, to be certified. Certifying these nurse aides will
- 8 allow the department of commerce and consumer affairs, the
- 9 department of human services, and the department of health to
- 10 monitor and evaluate the quality and competency of these nurse
- 11 aides practicing in the State.
- 12 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 13 amended by adding a new section to be appropriately designated
- 14 and to read as follows:
- 15 "§321- Enforcement. (a) The department shall adopt
- 16 rules pursuant to chapter 91 as related to investigation and
- 17 actions taken against certified nurse aides.

4	§346- Enforcement. (a) The director of human services	
5	shall investigate allegations of abuse, neglect, and	
6	misappropriation of an individual or their property committed by	
7	a certified nurse aide that is employed in a health care setting	
8	that is licensed or certified pursuant to chapter 91.	
9	(b) The director of human services shall provide the	
10	findings from the investigation under subsection (a) to the	
11	department of commerce and consumer affairs for the purposes of	
12	placement in the nurse aide registry."	
13	SECTION 4. Chapter 457A, Hawaii Revised Statutes, is	
14	amended by adding three new sections to be appropriately	
15	designated and to read as follows:	
16	"§457A- Definitions. As used in this chapter, unless	
17	the context clearly indicates otherwise:	
18	"Certified nurse aide" means a nurse aide who has met the	
19	requirements of this chapter.	
20	"Director" means the director of commerce and consumer	
21	affairs.	

1	"Medicare/medicald nurse alde" means a certified nurse alde
2	who works in a medicare or medicaid certified nursing facility.
3	"Nurse aide" means a person who performs a variety of
4	duties relating to patients and patient care working under the
5	supervision of a nurse, including but not limited to assisting
6	patients in all activities of daily living such as serving and
7	collecting food trays, and helping patients get out of bed,
8	bathe, and dress. A nurse aide may also assist a nurse by
9	changing bed linens, delivering messages, and sterilizing
10	instruments.

4	(e) Maintenance requirements for recertification shall be		
5	on a biennial basis, including employment in a medicare/medicaid		
6	facility as required by federal and state law.		
7	(f) No charge shall be imposed on nurse aides for the		
8	maintenance of the nurse aide registry.		
9	(g) Any person who works in a medicare/medicaid nursing		
10	facility who holds a valid certificate to practice as a		
11	certified nurse aide in this State shall have the right to use		
12	the title "certified nurse aide" and the abbreviation "C.N.A.".		
13	No other person shall assume the title "certified nurse aide" or		
14	in any manner imply that the individual is a certified nurse		
15	aide except as provided in this chapter or use the abbreviation		
16	"C.N.A." or any other words, letters, signs, or devices to		
17	indicate that the person using the same is a certified nurse		
18	aide.		
19	§457A- Nurse aide certification for state licensed or		
20	state certified facilities. (a) This certification applies to		
21	nurse aides working in state licensed and state certified health		

- 1 settings other than a medicare/medicaid certified nursing
- 2 facility.
- 3 (b) To be certified, an applicant shall successfully
- 4 complete training in a state-approved training program and a
- 5 nurse aide examination approved by the director.
- 6 (c) Fees may be imposed for services rendered to carry out
- 7 the purposes of this section.
- 8 (d) Reciprocity shall be granted to qualified nurse aides
- 9 who have completed a state-approved program where the
- 10 requirements of that program are comparable to the requirements
- 11 of this chapter.
- 12 (e) Maintenance requirements for recertification shall be
- 13 on a biennial basis, including a recertification examination as
- 14 approved by the department of human services.
- 15 (f) Any person who works in a state licensed or state
- 16 certified health care setting and who holds a valid certificate
- 17 to practice as a certified nurse aide in this State shall have
- 18 the right to use the title "certified nurse aide" and the
- 19 abbreviation "C.N.A.". No other person shall assume the title
- 20 "certified nurse aide" or in any manner imply that the
- 21 individual is a certified nurse aide except as provided in this
- 22 chapter or use the abbreviation "C.N.A." or any other words,

- 1 letters, signs, or devices to indicate that the person using the
- 2 same is a certified nurse aide. This section shall not apply to
- 3 medicare/medicaid nurse aides."
- 4 SECTION 5. Section 457A-1, Hawaii Revised Statutes, is
- 5 amended to read as follows:
- 6 "§457A-1 Findings and purpose. (a) The legislature
- 7 recognizes that 42 United States Code §1395i-3 and §1396R require
- 8 nurse aides working in certified nursing facilities participating
- 9 in medicare and medicaid programs to be certified.
- 10 (b) The legislature also recognizes that nurse aides who
- 11 work in State licensed or State certified health care settings
- 12 should be certified for the purpose of consumer safety and held to
- 13 similar standards of competency and evaluation appropriate for
- 14 these facilities. This chapter implements 42 United States Code
- 15 §1395i-3 and §1396R and this chapter with respect to:
- 16 (1) Establishing the State's regulatory scheme for
- 17 certifying nurse aides;
- 18 (2) Defining the scope of regulation;
- 19 (3) Establishing standards for certification and biennial
- 20 recertification; and

1	(4) Establishing an interagency agreement between the		
2	state agencies responsible for various aspects of the		
3	program.		
4	[(b) As used in this chapter, "nurse aide" means a person		
5	who performs a variety of duties relating to patients and patient		
6	care working under the supervision of a nurse, including but not		
7	limited to assisting patients in all activities of daily living		
8	such as serving and collecting food trays, and helping patients		
9	get out of bed, bathe, and dress. A nurse aide may also assist a		
10	nurse by changing bed linens, delivering messages, and sterilizing		
11	instruments.]"		
12	SECTION 6. Section 457A-2, Hawaii Revised Statutes, is		
13	amended to read as follows:		
14	"§457A-2 Implementation. (a) The director [of commerce and		
15	consumer affairs shall implement the provisions of 42 United		
16	States Code §1395i-3 and §1396R and this chapter, as they relate		
17	only to establishing:		
18	(1) The minimum requirements and standards necessary for		
19	certification as a nurse aide;		
20	(2) Examination requirements, including the passing score;		
21	(3) Maintenance requirements for continued certification		
22	on a biennial basis; and		

1 (4)Implementation of a nurse aide registry. 2 The director of the department of health shall implement 3 the provisions 42 United States Code §1395i-3 and §1396R and this 4 chapter, as they relate to disciplining of nurse aides employed in health care settings licensed or certified by the department of 5 6 health, certified under this chapter. 7 (c) The director of human services shall implement the 8 provisions of 42 United States code §1395i-3 and §1396R and this 9 chapter, as they relate to training programs for nurse aides and 10 recertification, and to disciplining of nurse aides employed in 11 health care settings licensed or certified by the department of human services, certified under this chapter." 12 13 SECTION 7. Section 457A-3, Hawaii Revised Statutes, is 14 amended to read as follows: "§457A-3 Power of director. (a) The director, in 15 16 accordance with chapters 91 and 92, shall adopt rules that may be 17 necessary to implement the provisions of this chapter and 42 18 United States Code §1395i-3 and §1396R, as well as the federal 19 regulations adopted pursuant thereto, as they relate only to 20 establishing: 21 (1) The minimum requirements necessary for certification

as a nurse aide;

10	(b)	The director shall issue certificates to qualified nurse
11	aides and	shall be responsible for maintenance of an up-to-date
12	nurse aid	e registry which shall include the names of certified
13	nurse aide	es, their places of employment, and [disciplinary
14	actions.]	the information that is required to be reported by the
15	department	t of health and the department of human services to the
16	director pursuant to sections 321- and 346 The director's	
17	role, with	n regard to certified nurse aides, [Disciplinary actions]
18	shall be	limited to the placement of substantiated findings from
19	the department of health and the department of human services int	
20	the nurse	aide registry [within ten working days of court
21	settlement]."	

- 1 SECTION 8. Any nurse aide employed in a State licensed or
- 2 State certified health care setting and who has been recertified
- 3 by June 30, 2006 may be recertified on a biennial basis under
- 4 this chapter if the nurse aide passes, by December 31, 2007, a
- 5 proficiency evaluation approved by the department of human
- 6 services. If the nurse aide fails to pass the evaluation, the
- 7 nurse aide shall instead apply for certification as a new
- 8 applicant and undergo recertification as required under this
- 9 chapter.
- 10 SECTION 9. Statutory material to be repealed is bracketed
- 11 and stricken. New statutory material is underscored.
- 12 SECTION 10. This Act shall take effect on July 1, 2006.
