BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The Hawaii Revised Statutes is amended by
2	adding a new chapter to be appropriately designated and to read
3	as follows:

6	§ -1 Purpose. Recognizing the magnitude of the many
7	problems and issues related to HIV/AIDS in Hawaii, including,
8	but not limited to costs, prevention, housing, food, drugs,
9	insurance, primary medical and dental care, social services,
10	need for coordination and development of public and private
11	policies, the purpose of this chapter is to establish a
12	statewide commission to promote and develop comprehensive
13	planning and policymaking to address current and emerging issues
14	relating to HIV/AIDS. The intent of the legislature is to
15	provide a comprehensive statewide planning and policymaking
16	process that:
17	(1) Promotes review and integration of local, regional,
18	and national HIV/AIDS planning activities; and

For purposes of subsection (b), the commission shall 3 engage in a public collaborative planning process and consider 4 recommendations from the public. 5 The commission shall maintain the security and 6 (d) confidentiality of data, documents, and other information or 7 materials developed in the course of conducting its duties and 8 functions to ensure a consistent review of trends and other 9 relevant information for the use of and availability to other 10 11 agencies and private organizations. The commission shall make recommendations to 12 13 government and private entities in relation to the duties and 14 functions of the commission. -4 Biennial policy recommendation; reports; 15 considerations. (a) The commission shall make biennial policy 16 17 recommendations that shall: 18 Take into account and shall seek to harmonize: (1)Roles, functions, plans, and needs of government 19 (A) and private entities statewide; 20 21 (B) Reviews and recommendations regarding resources;

(C) Changing health, social, legal, political, and 1 economic implications and impacts; and 2 (2) Provide directed dialog and advocacy in support of 3 defined policy recommendations. 4 The commission shall reflect a balance of the need for multi-5 discipline approaches and understanding of comprehensive 6 community-based planning for the complex issues related to the 7 health, social, legal, political, and economic elements of 8 HIV/AIDS and public well being and quality of life. 9 10 (b) The commission policy recommendations shall consider: Strategies and policies that maximize coordination and 11 (1)use of resources; 12 (2) Strategies that conserve limited resources; and 13 14 (3) Need for development of additional or changing resources to address issues and concerns. 15 16 The commission's policy recommendations shall be projected at least five years into the future. 17 18 S **Staffing.** The commission shall hire an executive director to conduct and coordinate the duties of the commission. 19 The executive director may hire a project specialist and other 20

staff as necessary."
