Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 2271, H.D. 1, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO NON-AGRICULTURAL PARK LANDS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this bill is to ensure proper use of the State's non-agricultural park lands by authorizing the Department of Agriculture to:

- (1) Dispose of public lands for agricultural or aquacultural purposes;
- (2) Plan, develop, and manage certain non-agricultural park lands; and
- (3) Negotiate leases for agricultural purposes.

Your Committee on Conference has amended this bill by:

- (1) Changing the effective date from July 1, 2050, to upon approval; and
- (2) Making technical, nonsubstantive amendments for clarity and style.

As affirmed by the record of votes of the managers of your Committee on Conference that is attached to this report, your Committee on Conference is in accord with the intent and purpose of H.B.
