Your Committee has amended this bill by:

- (1) Changing its effective date to July 1, 2020, to encourage further discussion; and

No. 2767, H.D. 1, as amended herein, and recommends that it pass Third Reading in the form attached hereto as H.B. No. 2767, H.D. 2.
