"HOUSE CONCURRENT RESOLUTION RESPECTFULLY REQUESTING THE PARTICIPATION OF THE GOVERNOR OR THE GOVERNOR'S DESIGNEE IN A JOINT LEGISLATIVE/EXECUTIVE BRANCH WORK GROUP DEDICATED TO FINDING AFFORDABLE SOLUTIONS TO HAWAII'S HEALTHCARE CRISIS,"

- (2) A consumer advocate.


Technical, nonsubstantive changes were also made for clarity, consistency, and style.
