Your Committee on Human Services, to which was referred H.C.R. No. 41 entitled:

"HOUSE CONCURRENT RESOLUTION RECOGNIZING MARCH AS CAREGIVERS' MONTH IN HAWAII,"

begs leave to report as follows:

The purpose of this concurrent resolution is to strongly commend the noteworthy efforts of caregivers. Specifically, this concurrent resolution:

- (1) Recognizes that the institution of democracy and the foundation of the United States of America is recognition that "we hold these truths to be selfevident, that all men are created equal, that they are endowed by their Creator with certain inalienable Rights, that among these are Life, Liberty, and the pursuit of Happiness" and that the actions of caregivers are exemplary of these core, founding values;
