- Abolish the Reproductive Rights Protection (RRP) Committee; and
- Provide for a resource list of advisors to assist the (2) Family Court, as needed, on sterilization issues relating to incapacitated adults.

The Disability and Communication Access Board, Judiciary, and State Council on Developmental Disabilities supported this bill.

Your Committee has amended this bill by:

- (1)Repealing the reference to the RRP Committee in section 560:5-612, Hawaii Revised Statutes;
- (2) Inserting a savings clause; and
- Making technical, nonsubstantive amendments for style, clarity, and consistency.
