Your Committee received testimony in support of DAVID W. HEYWOOD from the Department of Health. Mr. Heywood is currently serving on the Statewide Health Coordinating Council and is being nominated for a second term. Mr. Heywood received his MBA in 1983 and is currently the Executive Director, Hawaii Region, of United Healthcare.
