He has served on the Maui County Planning Commission as a member and the chair, as well as the vice chair of Maui County's Board of Variances and Appeals.

SAMUEL M. GON III is the senior scientist and cultural advisor for The Nature Conservancy of Hawai`i. He has also been an affiliate faculty member at University of Hawaii at Manoa's Department of Urban and Regional Planning since 1999. Dr. Gon holds a Bachelor of Science degree in zoology from the University of Hawaii at Manoa and a Masters degree in zoology and a Doctorate of Philosophy in animal behavior from the University of California, Davis.

Dr. Gon has over twenty-five years of experience in research and conservation in the Hawaiian islands and has worked with private, state, and federal entities on a variety of conservation and land management projects. He is also a Hawaiian cultural practitioner and underwent the traditional Hawaiian `uniki rites of passage to attain the status of kahuna kākalaleo.

Testimony in support of Mr. Edlao was submitted by the Department of Land and Natural Resources, Hawaii Pest Control Association, and one individual. Testimony in opposition to Mr. Edlao was submitted by the Conservation Council for Hawaii.

Testimony in support of Dr. Gon was submitted by the Department of Land and Natural Resources, the Office of Hawaiian Affairs, the Conservation Council for Hawaii, the Hawaii Conservation Alliance, the Hawaii Government Employees Association, KAHEA-The Hawaiian-Environmental Alliance, the Hawaii Chapter of the Sierra Club, and thirty-two individuals.
