Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 2004, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO HISTORIC PRESERVATION,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to establish the Ahu o Laka state monument and prohibit certain activities there.

Your Committee on Conference finds that there is a balance between preserving this cultural site, preventing future out-ofcontrol gatherings, and allowing recreational visitors to continue to use this area responsibly. Accordingly, your Committee on Conference believes that this measure achieves this balance by requiring the Department of Land and Natural Resources to adopt rules for the protection and maintenance of the Ahu o Laka state monument.
