Your Committee on Ways and Means, to which was referred S.B. No. 2738 entitled:

"A BILL FOR AN ACT AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS TO SUPPLEMENT ANY SHORTFALL TO ACQUIRE LAND TO EXPAND KAHUKU HIGH AND INTERMEDIATE SCHOOL,"

begs leave to report as follows:

The purpose of this measure is to authorize the issuance of general obligation bonds to supplement a funding shortfall in acquiring land to expand Kahuku high and intermediate school.

Your Committee finds that the additional funding is needed in order to complete a three-party land exchange and purchase that will enable the State to acquire a more suitable and safer site for the school.

Your Committee has amended this measure by:

- (1)Changing the appropriation to an unspecified amount;
- (2) Changing the effective date to July 1, 2006; and
- Making technical nonsubstantive amendments for the purposes of clarity and style.

As affirmed by the record of votes of the members of your Committee on Ways and Means that is attached to this report, your Committee is in accord with the intent and purpose of S.B.
