Your Committee on Ways and Means, to which was referred S.B. No. 304, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO WORKFORCE DEVELOPMENT,"

The purpose of this measure is to appropriate funds for the nursing and dental hygiene programs at the University of Hawaii.
