A BILL FOR AN ACT

RELATING TO UNFAIR BUSINESS PRACTICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1 | SECTION 1. Chapter 431, Hawaii Revised Statutes, is |

| 4 | "§431:10F- Directed suretyship; coercion of contractors. |
| 5 | (a) No person may require as a condition precedent to the |
| 6 | granting, awarding, or issuing a contract for the construction |
| 7 | or renovation of improvements to real property, that the person |
| 8 | whose obligation under such contract is to provide, construct, |
| 9 | or renovate improvements to real property is to acquire or |
| 10 | negotiate a surety bond or other contract guaranteeing |
| 11 | completion of such improvements through a particular surety |
| 12 | insurer or group of surety insurers, or a particular producer or |
| 13 | group of producers. |
| 14 | (b) The commissioner may examine and investigate the |
| 15 | insurance related activities of any person whom the commissioner |
| 16 | believes may be in violation of this section. Any person may |
| 17 | submit to the commissioner a complaint or any material pertinent |

to the enforcement of this section.
