BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 148, Hawaii Revised Statutes, is	
2	amended b	y adding a new section to part V to be appropriately	
3	designated and to read as follows:		
4	" <u>§14</u>	8- Seal of quality special fund. (a) There is	
5	establish	ed in the state treasury the seal of quality special	
6	fund, into which shall be deposited:		
7	(1)	All revenues from the operations of the seal of	
8		quality program established under section 148-61;	
9	(2)	Fines collected under section 148-66; and	
10	<u>(3)</u>	Any appropriations made by the legislature to the	
11		fund.	
12	(b)	Moneys in the special fund may be expended for all	
13	costs associated with the seal of quality program, including:		
14	(1)	Conducting trade shows, retail shows, conferences,	
15		seminars, and other promotional activities;	
16	(2)	Expenses for designs, program labels, items and	
17		materials, displays, brochures, media advertisements,	
18		inspection, and review and investigative activities

3	(3)	Printing, mailing, airfare and per diem, lei, decors,
4		rental of facilities and audio visual equipment,
5		display and booth fees, participation fees, general

8		program."
9	SECTION 2. There is appropriated out of the seal of	
10	quality special fund the sum of \$10,000 or so much thereof as	
11	may be necessary for fiscal year 2007-2008 for the seal of	
12	quality program.	
13	The sum appropriated shall be expended by the department o	
14	agriculture for the purposes of this Act.	
15	SECTION 3. New statutory material is underscored.	
16	SECTION 4. This Act shall take effect upon its approval;	
17	provided	that section 2 shall take effect on July 1, 2007.
