BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

16		adjuster's limited license;

20	(17)	\$600 per year for all services (including extension of
21		the license) for a regularly licensed limited line
22		motor vehicle rental company producer.

- 1 The services referred to in paragraphs (1) to $[(\frac{16}{16})]$ (17)
- 2 shall not include services in connection with examinations,
- 3 investigations, hearings, appeals, and deposits with a
- 4 depository other than the department of commerce and consumer
- 5 affairs."
- 6 SECTION 2. Section 431:9-228, Hawaii Revised Statutes, is
- 7 amended to read as follows:
- 8 "\$431:9-228 Place of business. [\(\frac{a}{a}\)\) Every licensed
- 9 adjuster, and independent bill reviewer shall have and maintain
- 10 in this State a place of business accessible to the public.
- 11 (b) (a) The place of business of every licensed adjuster
- 12 and independent bill reviewer shall be [that wherein] the place
- 13 where the licensee principally conducts transactions under the
- 14 licensee's [licenses.] license.
- 15 [(e)] (b) The licensee shall promptly notify the
- 16 commissioner of any change of business address."
- 17 SECTION 3. Statutory material to be repealed is bracketed
- 18 and stricken. New statutory material is underscored.
- 19 SECTION 4. This Act shall take effect on July 1, 2007.
