- 11 those cases to which the statute applies.

- 13 SECTION 5. All unexpended and unencumbered balances of the
- 14 appropriations made in this Act as of the close of business on
- 15 June 30, 2008, shall lapse.
- 16 SECTION 6. If any provision of this Act, or the
- 17 application thereof to any person or circumstance is held
- 18 invalid, the invalidity does not effect other provisions or
- 19 applications of the Act, which can be given effect without the
- 20 invalid provision or application, and to this end the provisions
- 21 of this Act are severable.
- 22 SECTION 7. This Act shall take effect upon its approval.
