# A BILL FOR AN ACT

RELATING TO VETERAN BURIAL GRANTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

	BE IT ENVIOLED BY THE EDGISERTORE OF THE STATE OF MINNING.
1	SECTION 1. The legislature finds that a Filipino veteran
2	of the New Filipino Scouts who enlisted between October 6, 1945,
3	and June 30, 1947, who died after June 30, 1994, and who was, at
4	the time of the veteran's death, a United States citizen and a
5	resident of the State of Hawaii, is entitled to receive a burial
6	grant from the office of veterans' services to pay for the cost
7	of:
8	(1) Providing funeral and burial services for the deceased
9	veteran; and
10	(2) Transporting the remains of the deceased veteran to

- (2) Transporting the remains of the deceased veteran to the Philippines.
- To qualify for this burial grant, however, the Filipino
  veteran's survivor or an interested party must produce an
  itemized paid invoice showing the specific services rendered on
  behalf of the deceased veteran. Because of the tremendous costs
  required to procure funeral and burial services, as well as
- 18 veterans, including the families and friends of these veterans,

- 1 cannot afford to pay for these activities in advance.
- 2 Consequently, some World War II Filipino veterans will not be
- 3 able to qualify for these burial grants from the office of
- 4 veterans' services because they cannot pay upfront costs
- 5 associated with funeral, burial, and transportation services to
- 6 be reimbursed at a later time. Because of these financial
- 7 constraints, the bodies of some deceased veterans could not be
- 8 properly buried until the deceased veteran's survivor or
- 9 interested parties raised the necessary funds to pay the
- 10 mortuary for funeral and other related services.
- 11 The legislature further finds under the Veterans Benefits
- 12 and Health Care Improvement Act of 2000 (Public Law 106-419),
- 13 many of the Filipino World War II veterans previously eligible
- 14 to participate in the state office of veterans' services program
- 15 regarding transportation of remains to the Philippines are now
- 16 eligible to be interred in state and federal veterans'
- 17 cemeteries. Therefore, in fairness to other veterans' survivors
- 18 who are not offered reimbursement for such transportation needs,
- 19 the payments made under this Act are properly limited to only
- 20 those veterans of the New Filipino Scouts who are not eligible
- 21 for interment in state and federal veterans cemeteries under the
- 22 Veterans Benefits and Health Care Improvement Act of 2000.

## H.B. NO. H.D. 1

- 1 This Act requires the office of veterans' services to 2 provide an alternative to the procedures currently specified in the rules of the office of veterans' services, which only apply 3 4 in situations where a deceased Filipino veteran's survivor or an 5 interested party has already paid for services rendered on behalf of the deceased veteran, or in situations where the 6 7 deceased veteran may have purchased a pre-paid funeral and 8 burial plan. The purpose of this Act, through the veterans' burial grant 9 10 program, is to pay directly to a mortuary or crematory the cost 11 of: 12 (1) Providing funeral and burial services at the request of a qualifying deceased Filipino veteran's survivor 13 14 or an interested party; and Transporting the veteran's remains to the Philippines, 15 (2) 16 upon the submission of a contract for services on behalf of the **17** deceased veteran and an itemized unpaid invoice. The amount 18 paid for funeral and burial services and transportation costs 19 shall not exceed \$ per person. 20 SECTION 2. Chapter 363, Hawaii Revised Statutes, is 21 amended by adding a new section to be appropriately designated

and to read as follows:

1	"§363- Disbursement of World War II Filipino veterans
2	burial grant funds. (a) At the request of a deceased (World
3	War II New Filipino Scout) survivor or an interested party, the
4	office of veterans' services shall receive, review, and, as
5	appropriate, approve requests for payments for:
6	(1) Providing funeral and burial services for a New
7	Filipino Scout who died after June 30, 1994; and
8	(2) Transporting the remains of a New Filipino Scout to
9	the Philippines.
10	(b) The office of veterans' services shall establish the
11	amount of burial grant funds that may be disbursed on behalf of
12	a New Filipino Scout; provided that the amount shall not exceed
13	\$ per person.
14	(c) The office of veterans' services shall not expend more
15	than the amount appropriated for the fiscal year to provide
16	burial grants for deceased World War II New Filipino Scouts).
17	(d) Specific eligibility criteria, application and appeal
18	procedures, service choices, and invoicing arrangements shall be
19	established by the office of veterans' services.
20	(e) Payment shall be authorized by the office of veterans'
21	services upon the submission of an itemized unpaid invoice

- 1 reflecting services that have been satisfactorily performed on
- 2 behalf of a deceased New Filipino Scout.
- 3 (f) As used in this section, "New Filipino Scout" means a
- 4 Filipino veteran who enlisted in the New Filipino Scouts between
- 5 October 6, 1945, and June 30, 1947, and who, at the time of the
- 6 veteran's death, was a United States citizen and a resident of
- 7 Hawaii."
- 8 SECTION 3. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so much
- 10 thereof as may be necessary for fiscal year 2007-2008 and the
- 11 sum of \$ or so much thereof as may be necessary for
- 12 fiscal year 2008-2009 for burial grant funds for deceased
- 13 Filipino veterans.
- 14 The sums appropriated shall be expended by the department
- 15 of defense, office of veterans' services for the purposes of
- 16 this Act.
- 17 SECTION 4. New statutory material is underscored.
- 18 SECTION 5. This Act shall take effect upon its approval;
- 19 provided that section 3 shall take effect on July 1, 2007.

Filipino Veterans; Burial

### Description:

Requires the office of veterans' services, at the request of a survivor or interested party of a deceased Filipino veteran who joined the New Filipino Scouts between October 6, 1945, and June 30, 1947, to make payment directly to a mortuary or crematory for funeral and burial services, and to transport the veteran's remains to the Philippines upon submission of an itemized unpaid invoice.
