
HOUSE CONCURRENT RESOLUTION

REQUESTING THE COMMITTEES ON HUMAN SERVICES OF THE SENATE AND THE HOUSE OF REPRESENTATIVES TO CONVENE A TASK FORCE DURING THE INTERIM TO FURTHER STUDY AND MAKE RECOMMENDATIONS REGARDING FAMILY COURT CUSTODY EVALUATOR ISSUES.

1 WHEREAS, in the 2006 Regular Session, the Senate and the
2 House of Representatives adopted Senate Concurrent Resolution
3 No. 52, S.D. 1, authorizing the Committees on Human Services of
4 the Senate and the House of Representatives to convene interim
5 hearings on the use of legal interventions available to the
6 Family Court; and

7
8 WHEREAS, during the course of the interim hearings, four
9 committees were formed relating to Family Court Models, Family
10 Court Sunshine and Accountability, Temporary Restraining Orders,
11 and the Best Interests of the Child; and

12
13 WHEREAS, after hours of hard work and meetings, the Family
14 Court Sunshine and Accountability Committee submitted its
15 findings and recommendations to the Committees on Human Services
16 of the Senate and the House of Representatives, which adopted
17 its recommendation regarding the need to further study certain
18 outstanding issues related to family court custody evaluators;
19 and

21 WHEREAS, the Family Court Sunshine and Accountability
22 Committee found that:

24 (1) The education, training, and experience standards for
25 family court custody evaluators should be further
26 explored and discussed; and

28 (2) Court-appointed custody evaluator models found in
29 other jurisdictions, such as California, should be
30 further explored and discussed before making a
31 determination if any model explored would be

1 appropriate for implementation in the Hawaii family
2 courts; now, therefore,
3

4 BE IT RESOLVED by the House of Representatives of the
5 Twenty-fourth Legislature of the State of Hawaii, Regular
6 Session of 2007, the Senate concurring, that the Committees on
7 Human Services of the Senate and the House of Representatives
8 are requested to convene a task force during the interim to
9 further study and make recommendations regarding the issues
10 identified by the Family Court Sunshine and Accountability
11 Committee regarding family court custody evaluators; and
12

13 BE IT FURTHER RESOLVED that the task force should include
14 one representative of the Judiciary, the Research Corporation of
15 the University of Hawaii, the legal community, a children's
16 advocacy organization, a social work organization, a domestic
17 violence organization, an organization representing the
18 interests of petitioners, and an organization representing the
19 interests of respondents; and

21 BE IT FURTHER RESOLVED that the task force is requested to
22 submit a report, including any proposed legislation, no later
23 than twenty days prior to the convening of the Regular Session
24 of 2008; and

26 BE IT FURTHER RESOLVED that certified copies of this
27 Concurrent Resolution be transmitted to the President of the
28 Senate, the Speaker of the House of Representatives, the Chair
29 of the Senate Committee on Human Services, the Chair of the
30 House Committee on Human Services, the Chief Justice of the
31 Hawaii Supreme Court, and the Executive Director of the Research
32 Corporation of the University of Hawaii.
