
HOUSE CONCURRENT RESOLUTION

REQUESTING A STUDY ON THE FEASIBILITY OF AN OPEN ROAD RACING
EVENT ON OAHU.

1 WHEREAS, there is substantial interest in holding open road
2 racing events for motor vehicles on the island of Oahu; and
3

4 WHEREAS, open road racing is a high speed race driven on
5 closed public highways; competitors attempt to set certain
6 speeds on a course of pre-determined length and to outrun each
7 other for the victory; and
8

9 WHEREAS, in Nevada, where open road racing is legal, there
10 are strict rules and requirements for each open road race; for
11 example, at the Silver State Classic Challenge each class of
12 cars specifies the safety equipment levels required for cars,
13 drivers, navigators, and a maximum speed, which may not be
14 exceeded for each individual class; and

16 WHEREAS, there is a strong auto racing culture in many
17 countries, in the United States, and particularly in California;
18 and

20 WHEREAS, to avoid illegal open road racing that often
21 endangers the public, legal open road racing events in strictly
22 controlled environments may provide a safe alternative
23 acceptable to drivers, fans, and the public; and

25 WHEREAS, the Legislature finds that an objective, reasoned
26 examination of issues relating to open road racing would assist
27 members in resolving this matter; now, therefore,

29 BE IT RESOLVED by the House of Representatives of the
30 Twenty-fourth Legislature of the State of Hawaii, Regular
31 Session of 2007, the Senate concurring, that the City and County
32 of Honolulu Department of Transportation Services and the state



1 Department of Transportation are requested to conduct a study on
2 the feasibility of holding open road racing events; and

4 BE IT FURTHER RESOLVED that the Department of
5 Transportation Services of the City and County of Honolulu and
6 the state Department of Transportation are requested to include
7 in the study the following:

- 9 (1) Analyze the feasibility of open road racing events on
- 10 the island of Oahu, including the location of possible
- 11 sites for racing courses, spectator stands, and any
- 12 concessions or services;
- 13
- 14 (2) Draft rules and necessary legislation required to hold
- 15 open road racing events;
- 16
- 17 (3) Analyze safety issues for the public and the
- 18 participants and establish requirements to provide
- 19 safe events;
- 20
- 21 (4) Determine the amount of fees to make each event self-
- 22 sustaining, taking into account required manpower to
- 23 set up each event, maintenance, and other issues; in
- 24 particular, the amount of entry fee for race
- 25 participants and for spectators;
- 26
- 27 (5) Assess the impact of road closure for open road races
- 28 on traffic, including public transportation; and
- 29
- 30 (6) Analyze potential financial opportunities for the
- 31 organizers, for example, fees generated for licenses
- 32 for concession stands selling food, drinks, and other
- 33 goods or services; and
- 34

35 BE IT FURTHER RESOLVED that certified copies of this
36 Concurrent Resolution be transmitted to the Governor, the
37 Director of Transportation, and the Mayor, the Chairperson of
38 the Council, the Managing Director, and the Director of the
39 Department of Transportation Services of the City and County of
40 Honolulu.
