
HOUSE CONCURRENT RESOLUTION

URGING ENDORSEMENT OF THE EARTH CHARTER AND ADOPTION OF ITS
CENTRAL PRINCIPLES AS PART OF THE FRAMEWORK FOR SUSTAINABLE
PLANNING AND DEVELOPMENT.

1 WHEREAS, the World Commission on Environment and
2 Development (a/k/a "the Brundtland Commission") first called for
3 "a universal declaration" and "new charter" to set "new norms"
4 to guide the transition to sustainable development in the mid-
5 1980s; and

6
7 WHEREAS, discussions led to a draft Earth Charter which was
8 discussed at the Earth Summit in Rio de Janeiro in 1992; and

9
10 WHEREAS, an independent Earth Charter Commission was formed
11 in 1997 to pull together several ongoing international
12 discussions and reach a global consensus on the Earth Charter;
13 and

14
15 WHEREAS, the Earth Charter is an authoritative synthesis of
16 values, principles, and aspirations that are widely shared by
17 growing numbers of people, in all regions of the world; and

18
19 WHEREAS, the four central principles of the Earth Charter
20 are: Respect and Care for the Community of Life; Ecological
21 Integrity; Social and Economic Justice; Democracy, Nonviolence
22 and Peace; and

23
24 WHEREAS, the Earth Charter is now being used as a basis for
25 peace negotiations, as a reference document in the development
26 of global standards and codes of ethics, as resource for
27 governance and legislative processes, as a community development
28 tool, as an educational framework for sustainable development,
29 and in many other contexts; and

1 WHEREAS, the Earth Charter is increasingly recognized as a
2 global consensus statement on the meaning of sustainability, the
3 challenge and vision of sustainable development, and the
4 principles by which sustainable development is to be achieved;
5 and

6
7 WHEREAS, the Earth Charter's principles of respect,
8 conservation, sustainability, sharing, equality, democracy,
9 tolerance, justice, and peace are consistent with the
10 recommendations of the Hawaii 2050 Sustainability Task Force;
11 and

12
13 WHEREAS, individuals, organizations, and governments
14 worldwide are being urged to endorse the Earth Charter; and

15
16 WHEREAS, the State of Hawaii seeks to be a leader in
17 incorporating principles of sustainability into planning
18 processes at all levels of government; now, therefore,

19
20 BE IT RESOLVED by the House of Representatives of the
21 Twenty-fourth Legislature of the State of Hawaii, Regular
22 Session of 2007, the Senate concurring, that the State of Hawaii
23 endorses the Earth Charter as part of a framework for
24 sustainable planning and development; and

25
26 BE IT FURTHER RESOLVED that the Governor, the mayors and
27 county councils, and the Hawaii 2050 Sustainability Task Force
28 are urged to adopt and utilize the Earth Charter as part of a
29 framework for sustainable planning; and

30
31 BE IT FURTHER RESOLVED that certified copies of this
32 Concurrent Resolution be transmitted to the Governor, the Mayor
33 and the Chairperson of the Council of each county, Hawaii's
34 congressional delegation, the Hawaii 2050 Sustainability Task
35 Force, and Earth Charter USA.
