### A BILL FOR AN ACT

RELATING TO HIGHWAY SAFETY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 286-209, Hawaii Revised Statutes, is
- 2 amended by amending subsection (a) to read as follows:
- 3 "(a) Motor carrier vehicles, including but not limited to
- 4 trucks, truck-tractors, semitrailers, trailers, or pole trailers
- 5 having a gross vehicle weight rating of more than [10,000] ten
- 6 thousand pounds, and motor carrier vehicles having a gross
- 7 vehicle weight rating of [10,000] ten thousand pounds or less
- 8 which transport passengers in the furtherance of a commercial
- 9 enterprise, including car rental transport vehicles shall be
- 10 inspected and certified [once every twelve months during the
- 11 month in which the vehicle's certificate of motor vehicle
- 12 registration is issued.] annually."
- 13 SECTION 2. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 3. This Act shall take effect on January 1, 2008.
