A BILL FOR AN ACT

RELATING TO THE BOARD OF REGENTS OF THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 304A, Hawaii Revised Statutes, is

- 3 widely viewed as having placed the broad public interest ahead
- 4 of special interests and have achieved a high level of
- 5 prominence in their profession and are respected by the

- 7 (f) Members of the council shall serve terms coterminous
- 8 with the Governor.
- 9 (g) If a vacancy occurs, a successor shall be appointed in
- 10 the same manner as the person's predecessor.
- 11 (h) The council shall operate in a wholly nonpartisan
- 12 manner. A member of the council shall not run for or hold any
- 13 elected office of the State, or its political subdivisions. Any
- 14 member of the council who decides to run for an elected office
- 15 of the State, or its political subdivisions, shall resign from
- 16 the council prior to filing nomination papers.

(j) Members of the council shall serve without 1 compensation but shall be reimbursed for expenses, including 2 travel, board, and lodging expenses, necessary for the 3 performance of their duties." SECTION 2. Chapter 304A-104, Hawaii Revised Statutes, is 5 amended by amending subsection (a) to read as follows: The affairs of the university shall be under the 7 general management and control of the board of regents 8 consisting of twelve members who shall be appointed by the 9 Governor from a list of qualified candidates presented to the 10 Governor by the Governor's candidate advisory council for the 11 Board of Regents of the University of Hawaii, and may be removed 12 by the Governor. The term of each member shall be for four 13 years; provided that the term of the student member shall be for 14 two years. Except as otherwise provided by statute, State 15 officers shall be eligible to appointment and membership. Every 16 member may serve beyond the expiration date of the member's term 17 of appointment until the member's successor has been appointed 18 and has qualified." 19 SECTION 3. There is appropriated out of the general 20 revenues of the State of Hawaii, the sum of \$50,000, or so much 21 thereof as may be necessary for fiscal year 2007-2008, and 22

JUSTIFICATION SHEET

DEPARTMENT:

TITLE:

A BILL FOR AN ACT RELATING TO THE BOARD OF REGENTS OF THE UNIVERSITY OF HAWAII.

PURPOSE:

The purpose of this bill is to implement the amendment to article X, section 6 of the State Constitution, proposed by the Legislature in 2005, and ratified by the voters in 2006, by establishing a Governor's advisory council to screen and propose candidates for appointment to the board of regents (BOR) of the University of Hawaii.

MEANS:

Add a new section to chapter 304A and amend section 304A-104(a), Hawaii Revised Statutes.

JUSTIFICATION:

It is the norm across the states for the governor to appoint the members of the governance structures for higher education. The Association for Governing Boards recommends the use of screening committees (AGB, #1, 2003), but it is important to note that the AGB cautions against screening bodies that are composed of special interest representatives.

On this matter, Richard T. Ingram, President of AGB, states:

"Governing boards should not have any 'designated slots,' because such a practice contradicts what public, citizen trusteeship is supposed to be: outstanding citizens who are independent in their individual and collective judgment who are there to serve the people of Hawaii -- not segments of the society, not special interests of any kind. Their primary duty is to hold the university's assets in trust for the current and future generations. It follows, therefore, that a screening committee should

not be composed of a collection of special interest representatives."

AGB recommends that the governor select the members of the screening committee in order to not further politicize the process by involving more players.

The council members and the process by which the governor's candidate advisory council screens and recommends applicants to the board should be nonpartisan. By nonpartisan, we mean that a person's party affiliation or the lack thereof should not be a consideration in appointing governor's candidate advisory council members; and the appointed governor's candidate advisory council members should not consider the political party affiliation or lack thereof of a potential nominee to the board in screening or recommending applicants to the board.

Impact on the public: A screening committee will provide wide consideration of outstanding individuals without regard to partisanship.

Impact on the department and other agencies:
The Board of Regents will be well-served to
have individuals appointed for their
independence of judgment. A screening
committee will provide further assurance
that the selections are not based on
politics or special interests.
