A BILL FOR AN ACT

RELATING TO GENETICALLY MODIFIED ORGANISMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 321-11.6, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "[+]\$321-11.6[+] Genetically modified organisms[-]; notification and certification. (a) Any person that proposes 4 5 to research, test, propagate, cultivate, grow, or produce any genetically modified organism shall: 6 7 (1) Notify the department of health of the person's intent 8 to conduct the activity; and Obtain certification of approval from the department 9 (2) 10 prior to conducting the activity. 11 The department shall examine and evaluate each (b) proposed genetically modified organism research project; 12 testing, propagating, cultivating, or growing technique; or 13 product for its risk to public health and to the environment. 14 15 The department shall issue a certification of approval after determining that the proposed genetically modified organism 16
