
A BILL FOR AN ACT

RELATING TO SHORT TERM INVESTMENT OF COUNTY MONEYS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 46-50, Hawaii Revised Statutes, is 1 2 amended to read as follows: 3 "\$46-50 Short term investment of county moneys. director of finance of each county may, with the approval of the 4 legislative body, invest county moneys which are in excess of 5 the amounts necessary for the meeting of immediate requirements 6 7 when in the judgment of the legislative body the action will not impede or hamper the necessary financial operations of the 8 9 county in: 10 (1) Bonds or interest-bearing notes or obligations: (A) Of the county; 11 12 (B) Of the State: (C) Of the United States; or 13 14 (D) Of agencies of the United States; for which the full faith and credit of the United 15 States are pledged for the payment of principal and 16 17 interest;
