# SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF ATTORNEY GENERAL TO CONVENE A TASK  
FORCE TO INVESTIGATE AND COORDINATE THE PROVISION OF  
MEDICAL, EDUCATIONAL, HOUSING, AND SOCIAL SERVICES TO  
MIGRANTS FROM FREELY ASSOCIATED STATES.

1           WHEREAS, The Compact of Free Association defines the  
2 relationship that the Federated States of Micronesia, the  
3 Republic of the Marshall Islands, and the Republic of Palau have  
4 as associated states with the United States; and

5  
6           WHEREAS, under the Compact, the United States provides  
7 direct economic assistance, federal services, and military  
8 protection to the associated states in exchange for defense  
9 rights; and

10  
11           WHEREAS, under the Compact of Free Association, Freely  
12 Associated States citizens can migrate in and out of Hawaii  
13 without visas or other immigration requirements; and

14  
15           WHEREAS, it is estimated that over eight thousand Freely  
16 Associated States citizens have migrated to Hawaii; and

17  
18           WHEREAS, this migration has had a significant financial  
19 impact on Hawaii in terms of un-reimbursed health care,  
20 education, public safety, and welfare costs; and

21  
22           WHEREAS, since the federal government continues to provide  
23 inadequate federal medical and welfare assistance to Freely  
24 Associated States citizens who migrated to Hawaii and other  
25 parts of the United States, many rely on state aid; and

26  
27           WHEREAS, it is reported that the health care and education  
28 cost of migrants from the Freely Associated States to Hawaii  
29 alone was \$86,000,000 between 1996 and 2000; and

1 WHEREAS, there are high rates of tuberculosis, hepatitis B,  
2 and syphilis reported among migrants from the Freely Associated  
3 States; and

5 WHEREAS, there is no centralized plan for the provision of  
6 medical and social services to this population; and  
7

8 WHEREAS, a task force should be convened to investigate and  
9 coordinate the provision of medical and social services to  
10 migrants from Freely Associated States; now, therefore,  
11

12 BE IT RESOLVED by the Senate of the Twenty-fourth  
13 Legislature of the State of Hawaii, Regular Session of 2007, the  
14 House of Representatives concurring, that the Department of the  
15 Attorney General is requested to convene a task force to  
16 investigate and coordinate the provision of medical and social  
17 services to migrants from Freely Associated States; and

19 BE IT FURTHER RESOLVED that the task force include a  
20 representative of:

41 BE IT FURTHER RESOLVED that the task force is requested to:

- 43 (1) Consult with the Department of the Interior's Office  
44 of Insular Affairs in Hawaii regarding what federal



1 funds and services are available to assist Freely  
2 Associated States citizens in Hawaii;

4 (2) Research whether a current census exists regarding the  
5 number of Freely Associated States citizens living,  
6 working, and attending school in Hawaii, and if no  
7 data exists, consult with the United States Census  
8 Bureau on obtaining this information in future  
9 national or regional census; and

10  
11 (3) Investigate the medical, educational, housing, and  
12 social services needs of migrants from Freely  
13 Associated States, including the impact these service  
14 needs have on schools, and make recommendations  
15 regarding how to plan for and coordinate the provision  
16 of services to this population; and

17  
18 BE IT FURTHER RESOLVED that the task force is requested to  
19 submit an interim report to the Legislature no later than twenty  
20 days prior to the convening of the 2008 Regular Session, and to  
21 submit a final report to the Legislature no later than twenty  
22 days prior to the convening of the 2009 Regular Session on the  
23 actions taken, information gathered, and any recommendations  
24 made by the task force; and

26 BE IT FURTHER RESOLVED that certified copies of this  
27 Concurrent Resolution be transmitted to the Attorney General,  
28 the Director of Health, the Director of Human Services, the  
29 Chair of the Board of Education, the Director of Labor and  
30 Industrial Relations, the Dean of the John A. Burns School of  
31 Medicine, the Dean of the University of Hawaii- West Oahu, the  
32 Director of the Department of the Interior's Office of Insular  
33 Affairs in Hawaii, the President of Micronesians United, the  
34 President of the Micronesian Community Network, the Director of  
35 the Institute for Human Services, and the members of Hawaii's  
36 delegation to the Congress of the United States.
