Your Committee on Finance, to which was referred H.B. No. 275
entitled:

"A BILL FOR AN ACT RELATING TO THE UNIFORM ATHLETE AGENTS
ACT,"

begs leave to report as follows:

The purpose of this bill is to protect student-athletes and
educational institutions from potentially unscrupulous practices
of athlete agents.

The University of Hawaii (UH), UH-Manoa and UH-Hilo athletic
departments, and the Hawaii Commission to Promote Uniform
Legislation testified in support of this bill. The Department of
Education supported the intent of this measure. The Department of
Commerce and Consumer Affairs opposed this bill.

Your Committee has amended this bill by:

- (1) Changing the effective date to July 1, 2020, to
encourage continued discussion; and
- (2) Making technical, nonsubstantive amendments for clarity,
consistency, and style.



As affirmed by the record of votes of the members of your Committee on Finance that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 275, as amended herein, and recommends that it pass Third Reading in the form attached hereto as H.B. No. 275, H.D. 1.
