Your Committee on Finance, to which was referred H.B. No. 751  
entitled:

"A BILL FOR AN ACT RELATING TO EMPLOYMENT SECURITY,"

begs leave to report as follows:

The purpose of this bill is to support workforce and economic  
development by:

- (1) Extending the time period in which the Department of  
Labor and Industrial Relations (DLIR) may expend Reed  
Act monies appropriated under Act 190, Session Laws of  
Hawaii 2006 (Act 190);
- (2) Removing restrictions placed on funds used by the  
Workforce Development Council that conflict with federal  
restrictions; and
- (3) Providing DLIR with up to 10 percent of these funds for  
administrative purposes.

DLIR, the Workforce Development Council, and the Workforce  
Investment Boards of the City and County of Honolulu, County of  
Maui, County of Hawaii, and County of Kauai testified in support  
of this bill.



Your Committee has amended this bill by:

- (1) Changing its effective date to June 29, 2007; and
- (2) Making technical, nonsubstantive amendments for clarity, consistency, and style.

As affirmed by the record of votes of the members of your Committee on Finance that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 751, as amended herein, and recommends that it pass Third Reading in the form attached hereto as H.B. No. 751, H.D. 1.
