HTA supported the intent of this measure.


Your Committee finds that safety and security is one of the
nine strategic initiatives identified in the Hawaii Tourism
Strategic Plan. HTA has been involved in various measures over
the past few years to support visitor safety and security,
including funding for the Visitor Assistance Program and
development of the "travelsmarthawaii" web site. In addition, HTA
has selected a contractor to develop a safety and security plan
and is also working with other organizations to develop water
safety materials.

Committee on Tourism & Culture that is attached to this report,
your Committee concurs with the intent and purpose of H.R. No. 118
and recommends its adoption.
