Your Committees on Higher Education and Labor & Public  
Employment, to which was referred H.R. No. 139 entitled:

"HOUSE RESOLUTION REQUESTING THAT THE UNIVERSITY OF HAWAII  
SUBMIT A REPORT WITH INFORMATION REGARDING THE SALARIES OF  
UH-MANOA FACULTY AND ADMINISTRATORS,"

beg leave to report as follows:

The purpose of this resolution is to request the University  
of Hawaii to submit a report with information regarding the  
salaries of UH Manoa faculty and administrators.

The University of Hawaii Professional Assembly and one  
concerned individual submitted testimony in support of this  
resolution. The University of Hawaii opposed this measure in its  
current form, and commented on how certain information could be  
reported to the Legislature on a departmental basis rather than on  
individual cases as requested.

Based on testimony received your Committees have amended this  
measure by:

- (1) Requesting that the salaries of executives and  
management be included in the report; and
- (2) Removing certain provisions originally requested to be  
included in the report; and

- (3) Changing the title of this resolution to read:  
"REQUESTING THAT THE UNIVERSITY OF HAWAII SUBMIT A  
REPORT WITH INFORMATION REGARDING THE SALARIES OF UH-  
MANOA EXECUTIVES, MANAGEMENT, FACULTY AND  
ADMINISTRATORS"; and
- (4) Making technical, nonsubstantive amendments for clarity,  
consistency, and style.

As affirmed by the records of votes of the members of your  
Committees on Higher Education and Labor & Public Employment that  
are attached to this report, your Committees concur with the  
intent and purpose of H.R. No. 139, as amended herein, and  
recommend that it be referred to the Committee on Finance, in the  
form attached hereto as H.R. No. 139, H.D. 1.


