The purpose of this resolution is to request a management  
audit of the Historic Preservation Division of the Department of  
Land and Natural Resources.

The Office of Hawaiian Affairs and Hawaii Government  
Employees Association, AFSCME Local 152, AFL-CIO submitted  
testimony in support. The Society for Hawaiian Archaeology  
supported this measure with reservations. The Department of Land  
and Natural Resources opposed this resolution. A concerned  
individual provided comments.

Your Committee has amended this resolution by:


- (1) Including additional information on staff member  
turnover; and



- (2) Including additional language to request that the Auditor interview former Division staff and candidates for positions within the Division to evaluate Division management practices, including recruitment, hiring, and employment practices.
